Subject: Request to properly implement and circulate the Standard protocol for the adoption of community animals- regarding.

Sir/Madam,

The Animal Welfare Board of India (AWBI) is a Statutory Body established under the Prevention of Cruelty to Animal Act, 1960 and is an apex body for protection and safeguard the rights of animals as well to ensure that the five freedoms of the animals are upheld and no animals are subject to any unnecessary pain or suffering.

- 2. In this regard, the Supreme Court has in the case of AWBI Vs. Nagaraja & Ors. inter alia held that "We declare that the five freedoms [viz. (i) freedom from hunger, thirst, and malnutrition; ii) freedom from fear and distress iii) freedom from physical and thermal discomfort iv) freedom from pain, injury and disease; and v) freedom to express normal patterns of behaviour, referred to earlier be read into section 3 and 11 of Prevention of Cruelty to Animals Act, 1960, be protected and safeguarded by the State and Central Government, Union Territories (in short "Governments"), Ministry of Environment, Forest and Climate Change and AWBI."
- 3. ABWI has been receiving several queries regarding procedure for adopting the community dogs as there is a growing compassion and awareness of the benefits of the community animals among the citizens of the country.
- 4. It is pertinent to mention that the Indigenous dog breeds of India are naturally healthy and well-adjusted to the local climate are found on the streets fending for themselves. There are numerous Indigenous dogs in our streets and in shelters across the country which make excellent pets, for their exceptional qualities.

- 5. Accordingly, the AWBI has prepared a procedure for the adoption of the community dogs, detailing the necessary protocol which must be followed while adopting a community dog to ensure the proper welfare of the animals and to prevent any unnecessary pain or suffering to the animals. w
- 6. All the authorities may bring this advisory / guidelines to all the local bodies / NGOs / SPCA for necessary action.

#### STANDARD PROTOCOL FOR ADOPTION OF COMMUNITY ANIMALS

For adoption of Community animals i:e dogs/pups from shelters or street, the following standard protocol may be followed, for necessary follow up and wellbeing of the animal as well as of the adopter.

## I.Where can one adopt a dog/pup from?

Dogs/pups can be adopted from shelters of SPCA or of Animal Welfare Organisations(AWO) recognized with the AWBI or State Animal Welfare Board by issuing adoption certificate. If one has adopted a dog/pup from the street, adoption papers can be processed through any Municipal Council / Municipal Corporation / Municipality / Panchayats or any acting legal authority / District SPCA along with medical check-up and vaccination.

## II. Who can adopt a dog/pup:

- 1. The person desirous of adopting a pet must be older than 18 years old.
- 2. The person must be of sound mind.
- 3. The person must be capable of providing adequate care & maintenance, including but not limited to adequate nutrition, veterinary care and housing.

## III. Documents to be submitted:

The following documents shall be submitted to the animal welfare organisation/SPCA by the person desirous of adopting a pet-

- 1. House-check form (appended at Annexure I).
- 2. Valid Government photo ID & address proof.
- 3. Completed adoption form (appended at Annexure II).

\*Paperwork Formalities include filling an Adoption Form and submission of copies of above mentioned ID Proof with Passport Size Photograph. The person adopting shall sign at every page, and self-attest the photo-ID & address proof copies.

#### IV. Procedure:

- 1. The House Check Form may be used for preliminary screening. The AWO from which the dog has been adopted or being adopted /Society for Prevention of Cruelty to Animals (SPCA) may assess and evaluate eligibility through a pre-and/or post-adoption house check and verify the information provided. The house check may be even conducted through a video call.
- 2. The person adopting the dog/pup shall take it for a veterinary check-up, and ensure vaccinations, parasite control, deworming or any other necessary medical treatment.
- 3. If the animal has attained maturity, it must be spayed/neutered prior to adoption.

- 4. The AWO from which the dog has been adopted or being adopted /SPCA upon being satisfied with the pre and/or post adoption check, veterinary check-up, inoculation etc, may issue an adoption certificate mentioning species and age of the dog/pup and may provide documents for appropriate guidance for care and maintenance of the community animal.
- 5. The AWO/SPCA must maintain a record of all animals adopted through it for last 2 years.

## V. Pet friendly house:

- 1. In apartments or houses with multiple floors, the balconies and windows must be netted to avoid the risk of the pet escaping or falling.
- 2. Preferably, the Sharp or dangerous objects shall be covered or kept away from the reach of the pet.
- 3. The AWO / SPCA should inform the adopting family in advance regarding certain harmful plants, chemicals, incense sticks and food items which are toxic to pets, with guidance of a veterinarian.
- 4. Preferable, electrical fittings accessible to pet shall be covered with tape.
- 5. Comfortable bedding shall be provided for the pet in a suitable spot in the house.
- 6. Pet must have free access to clean drinking water at all times.
- 7. Regular and species appropriate meals shall be provided to the pet.
- 8. Dogs/puppies shall be walked at least twice a day.
